BFB-IS-7 Maintenance of the University Payroll System has undergone a technical review and was identified as obsolete and not needed, thus it is being rescinded. This policy was issued but was never adopted. Also, IS-7 dealt with the development of Personnel Payroll System (PPS). PPS is no longer being actively developed, thus, the policy is no longer needed. The University also has completed the migration to UC Path. UC Path is covered by BFB-IS-3 Electronic Information Security Policy. The relevant information outlined in IS-7 was incorporated into IS-3.

Dear Colleagues:

Enclosed are two policies that have gone through systemwide comprehensive and technical reviews, and their dispositions have been approved:

1. *Revised Policy on Protection of Human Subjects in Research* has undergone a systemwide comprehensive review. Revisions to the policy include the following:
 - A new definition section for the Policy.
 - An explanation of the ethical principles that the University follows for Human Subjects Research.
 - A statement that the University's commitment to Human Subjects applies to all Human Subjects Research in which the University is engaged, regardless of funding source or the institution that provided the IRB review.
 - An explanation that campuses may replace specific Common Rule requirements with commensurate protections for Human Subjects when the University is engaged in research that is not subject to the Common Rule (e.g., research that is not federally-funded or otherwise subject to federal oversight).
 - A description of the responsibilities of the campuses, IRBs, other oversight offices and committees, and researchers for compliance with this Policy.
2. *BFB-IS-7 Maintenance of the University Payroll System* has undergone a technical review and was identified as obsolete and not needed, thus it is being rescinded. This policy was issued but was never adopted. Also, IS-7 dealt with the development of Personnel Payroll System (PPS). PPS is no longer being actively developed, thus, the policy is no longer needed.
