Delegation of Authority to Join Multi-University Member Limited Liability Company (UTLP) to Facilitate Licensing of University Patent Assets

Bylaw 22.2(c) of The Regents states that:

On September 17, 2020, the Board of Regents approved UCB’s participation in the limited liability company to be known as the University Technology Licensing Program, LLC (UTLP) to facilitate licensing of University patent assets. The approval included an authorization for the President to approve and execute, after consultation with UC Legal and the UCOP Office of Research and Innovation:

- (i) any documents reasonably required to join UTLP, consistent with the terms and conditions of the Regents approval; and
- (ii) any modifications, addenda, or amendments thereto, provided such amendments or other documents are materially consistent with the terms and conditions as set forth in the Regents approval.

The above authorities granted to me pursuant to the Board of Regents approval on September 17, 2020 are delegated to you as Chancellor of the Berkeley campus, effective December 14, 2020. Per the Board of Regents approval, the President retains the sole authority to make any appointments on behalf of UCB to the board of UTLP, and UCB is not authorized to directly contribute any campus funds towards the operation of UTLP other than funds generated by UTLP and applied toward operations in accordance with the UTLP agreement.

This authority may only be re-delegated to the Vice Chancellor with oversight of the technology licensing program of the campus.
